

# Coastal Plains Education Charter High School

## Partner High School Course Options

### Spring/Summer 2021

Coastal Plains Education Charter High School is a high school with a statewide attendance zone. Any student in the state of Georgia can attend Coastal Plains if they meet age and attendance requirements. Students from partner high schools in Camden, Candler, Coffee, Colquitt, Evans, Glynn, Grady, Jeff Davis, Liberty, Long, Lowndes, Screven, Vidalia and Wayne counties may participate in special course programs offered in spring and summer pending space availability.

#### **1. Spring 2021 Partner Course for Seniors (January to May)**

- a. This is an option only when the site-directors and partner high school principals agree to the process and procedures and when room is available at Coastal Plains.
- b. This is an option for seniors enrolled in our Partner High Schools who need 1 or 2 credits in addition to their current daily class load in order to graduate in May 2021.
- c. The enrollment of these students can only occur with a signed application from their high school counselor indicating the course(s) needed.
- d. All non-FTE students must pay the \$150.00 per course fee. (Note: School Districts can provide payment)
- e. Payments should be paid online with Coastal Plains once the student is approved for the classes needed. NO CASH nor Personal checks accepted.
- f. This option is available once site directors indicate the amount of room and time that can be offered for this option. Each site director should communicate with their partner high school administration to confirm the available space.
- g. Partner high schools can work out additional support structures with Coastal Plains.

#### **2. Summer 2021 Partner Course for Students (May 30-July 31)**

- a. This is an option only when site-directors and high school principals agree to the process and procedures and when room is available at Coastal Plains (dates may vary).
- b. In some occasions, partner high schools can use computers and software during daytime school hours to allow students the opportunity to catch up on coursework that students need to get back on track. Some partner high school may use this for subject specific needs (math classes) which their students are struggling.
- c. When space is available, students may attend school during Coastal Plains hours (4:00-8:00 p.m. during the summer). Once again, students from partner high

schools can only be enrolled with permission from their high school counselor indicating the course that each student needs to complete.

- d. All non-FTE students must pay the \$150.00 per course fee. School Districts may pay for these courses.
- e. Payments should be paid online with Coastal Plains once the student is approved for the classes needed. NO CASH nor Personal checks accepted.
- f. Once again, Coastal Plains will be open Monday-Thursday (4:00-8:00 p.m.) and will be off July 1st – 4<sup>th</sup>. Space is based on the amount of room that each Coastal Plains site may have available. These spaces should be communicated between the site directors and partner high school administration.
